R/O observed a traffic accident the 100 block of Independence Avenue, SE. A WALES/NCIC check of the individual driving the striking vehicle was conducted, which revealed the Suspect had an active misdemeanor Bench Warrant issued through the Superior Court of the District of Columbia, and no permit status in the District of Columbia, Maryland, or Virginia. The Suspect also displayed behaviors indicating potential impairment. SFSTs were conducted and, due to numerous signs of impairment, the Suspect was placed under arrest and transported to headquarters for processing.

During an inventory search of the vehicle, R/O recovered a loaded firearm from the front passenger floorboard. CSS responded and processed the scene.
