R/O responded to the 400 block of Washington Avenue, SW, to assist with a traffic stop. Upon arrival, R/O observed heavy damage to the front end of the vehicle. While speaking with the Suspect, R/O detected an odor of an alcoholic beverage emitting from the Suspect's breath, along with what appeared to be a bottle of a clear alcoholic beverage on the driver-side floorboard. SFSTs were conducted and, due to numerous signs of impairment, the Suspect was placed under arrest and transported to headquarters for processing.
