R/O observed a vehicle traveling in the unit block of G Street, NE, pass his vehicle, going into the oncoming lane, and then failing to come to complete a stop at the stop sign at the intersection of First and G Streets, NE. R/O conducted a WALES/NCIC check of the vehicle's tags, which returned to a different vehicle. A traffic stop was conducted in the unit block of Columbus Circle, NE. The Suspect refused to produce any form of government identification, and was subsequently placed under arrest. A WALES/NCIC check revealed the Suspect had no valid permit in the District of Columbia, Maryland, or Virginia. While conducting an inventory search of the Suspect's vehicle, the R/O located a firearm, two magazines, and additional ammunition in a bag on the front passenger's seat. R/O observed a vehicle traveling in the wrong direction of traffic in the 500 block of C Street, NE. A traffic stop was conducted in the 400 block of C Street, NE. Upon approaching the vehicle, R/O observed what appeared to be a firearm and a magazine on top of the front dashboard of the vehicle. The Suspect was placed under arrest and transported to Headquarters for processing. CSS responded and recovered a .40 caliber pistol and one large capacity magazine containing nine rounds of ammunition. A WALES/NCIC check of the firearm revealed no registration in the District of Columbia.
