ADDITIONAL CHARGES: SECOND DEGREE CRUELTY TO CHILDREN

R/O responded to the unit block of Third Street, SW, to assist with a stop of a Suspect who may have been intoxicated while pushing a stroller with a child inside. R/O detected an odor of an alcoholic beverage emitting from the Suspect's breath. SFSTs were conducted and, due to numerous signs of impairment, the Suspect was placed under arrest and transported to Headquarters for processing. Upon further investigation, R/O found the child was wrapped in a wet blanket, and had not eaten since the night before. CIS was contacted and notified DC CFSA for the child.

A WALES/NCIC check of the vehicle's tag and Suspect revealed the tag belonged to another vehicle, and the Suspect had an expired District of Columbia permit.
