R/O observed a vehicle traveling at a high rate of speed southbound in the 600 block of North Capitol Street, NW, with no tag displayed. R/O conducted a traffic stop in the unit block of E Street, NW. A WALES/NCIC check revealed the temporary tag displayed in the front windshield was not on file, and the Suspect had no driver's license status in the District of Columbia, Maryland, or Virginia. The Suspect was placed under arrest and transported to Headquarters for processing.

The Suspect was placed under arrest and transported to Headquarters for processing. CSS responded and processed the scene. Test results of the white, powdery substance were positive for Fentanyl.
