R/O observed a vehicle traveling northbound in the 400 block of Second Street, NW, and pass through a solid red traffic signal at the intersection of Second and E Streets, NW. R/O conducted a traffic stop in the 600 block of New Jersey Avenue, NW. Upon approaching the vehicle, R/O noticed the Suspect's eyes were watery and glassy. A WALES/NCIC check of the vehicle's registration revealed that the tags belonged to a different vehicle, and the Suspect did not have a valid license in the District of Columbia, Maryland, or Virginia. While conducting SFSTs, R/O detected an odor of an alcoholic beverage was emanating from the Suspect's breath and person. Due to numerous signs of impairment, the Suspect was placed under arrest and transported to Headquarters for processing.

R/O observed a vehicle at a traffic signal sit through two light cycles in the 500 block of South Capitol Street, SW. R/O conducted a traffic stop in the same location. Upon approach, R/O observed the Suspect unconscious and slumped over the in the driver seat with the engine running. While speaking with the Suspect, R/O detected an odor of an alcoholic beverage emitting from the Suspect's breath. R/O-2 observed a firearm loaded with a large capacity magazine in the center console while conducting a search incident to arrest.
