R/O observed a vehicle with a flat left tire in the 200 block of Washington Avenue, SW. A traffic stop was conducted in the same location. A WALES/NCIC check of the Suspect returned an armed and dangerous caution, and two active warrants. R/O conducted an administrative search of the Suspect, and located a box cutter with a blade. Upon further investigation, a baggy containing a crystalized, rock-like substance was also found, which later tested positive for Methamphetamine. CSS responded and processed the scene. The Suspect was placed under arrest and transported to Headquarters for processing.

The Suspect was placed under arrest and transported to Headquarters for processing. During an inventory search, a folding tactical knife was recovered from the Suspect's pocket.
