R/O confirmed the vehicle's status through USCP Communications, and attempted to initiate a traffic stop, when the Suspects fled at a high rate of speed, heading eastbound in the 300 block of Pennsylvania Avenue, SE. R/O observed the vehicle commit several traffic offenses while fleeing before proceeding through a stop sign at the intersection of Twelfth Street and Independence Avenue, SE, and colliding with another vehicle.
