**ADDITIONAL CHARGES:** ADW - OTHER WEAPON (MOLOTOV COCKTAIL); POSSESSION OF A DESTRUCTIVE DEVICE; RESISTING ARREST

R/Os responded to the unit block of Massachusetts Avenue, NW, for a report of a male with a Molotov cocktail. R/Os arrived on scene and observed the Suspect attempting to ignite a glass bottle containing a colored liquid with a piece of white cloth stuffed into the bottle's opening. Upon approach, the Suspect refused all verbal commands, and attempted to flee westbound on Massachusetts Avenue away from the Officers. The Suspect became violently combative, and both R/Os were bitten during the arrest. During the search incident to arrest, a two-liter soda bottle with translucent liquid consistent with the appearance and odor of gasoline were found inside the Suspect's bag. The Suspect was placed under arrest and transported to Headquarters for processing. CSS responded and processed the scene.

R/O responded to the scene of a property-damage-only traffic accident in the unit block of Columbus Circle, NE. During the traffic crash investigation, the Suspect advised R/O that there was a handgun on

the vehicle's center console in plain view. R/O observed a black, holstered handgun in that location. Multiple rounds of ammunition and a large capacity magazine were also discovered in the vehicle. The Suspect was placed under arrest and transported to Headquarters for processing. CSS responded and processed the scene.
