R/O responded to the unit block of D Street, NE, for the report of a robbery. R/O made contact with the Complainant who stated she had been assaulted and robbed. She positively identified the Suspect who was sitting on a bench nearby. The Complainant stated that the Suspect ripped a bag out of her arms causing her to sustain an injury. The Suspect then broke the items in the bag by throwing the bag to the ground, and threatened to kill the Complainant. The Suspect was placed under arrest and transported to Headquarters for processing. CSS responded and processed the scene.

ADDITIONAL CHARGES: FUGITIVE FROM JUSTICE; TRAFFIC - NO VALID PERMIT; FAILURE TO ID SELF R/O observed a vehicle run a red light at the intersection of South Capitol Street and Independence Avenue, SE. A traffic stop was conducted in the unit block of Independence Avenue, SE. The Suspect provided what appeared to be a fraudulent operator's permit. A WALES/NCIC check did not show a return for the permit. While the Suspect was being placed under arrest, R/O observed a Maryland Identification Card with a different name.
