While speaking with the driver, R/O detected an odor of an alcoholic beverage emitting from the Suspect's breath. A WALES/NCIC check revealed the Suspect's permit was suspended in the District of Columbia. SFSTs were conducted and, due to numerous signs of impairment, the Suspect was placed under arrest and transported to Headquarters for processing.
