ADDITIONAL CHARGES: POSSESSION OF UNREGISTERED AMMUNITION; UNLAWFUL POSS FIREARM - MISD

At approximately 1335 hours, R/O observed a vehicle parallel parked in the middle of the intersection of Second Street and Washington Avenue, SW. The Suspect had exited the vehicle and walked north in the roadway of the 100 block of Washington Avenue, SW. R/O made contact with the Suspect and asked if there was a gun in the vehicle, to which the Suspect advised there was a pistol in the center console. The Suspect was placed under arrest and transported to Headquarters for processing.

ADDITIONAL CHARGES: ASSAULT ON A POLICE/FIRE FELONY (3 TIMES); RESISTING ARREST; DESTRUCTION OF PROPERTY \$1000+ - FELONY

R/O, while at the security checkpoint located at the intersection of Louisiana and New Jersey Avenues, NW, made contact with an individual attempting to enter the established fenced perimeter while on foot. The Suspect refused to provide identification, and when R/O directed the Suspect to step back outside the fence, the Suspect did not comply. While being detained by R/O, R/O-2, and R/O-3, the Suspect failed to comply with Officers' instructions, and continued to resist arrest and

fight the Officers. The Suspect was placed under arrest and transported to Headquarters for processing. During the fight to handcuff the Suspect, all three Officers sustained minor injuries. A marked USCP patrol vehicle, stationed at the security checkpoint, sustained extensive damage.

ADDITIONAL CHARGES: TRAFFIC LEAVING SCENE - PROPERTY DAMAGE

R/O responded to the intersection of D Street and Louisiana Avenue, NW, for the report of a traffic accident. The investigation revealed that the Suspect struck the rear bumper of a vehicle and fled the scene. A Metropolitan Police Department (MPD) Officer witnessed the Suspect strike a vehicle with their car and flee. The MPD Officer attempted to stop the Suspect's vehicle, however the Suspect proceeded westbound on D Street, NW. The Suspect made a U-turn at the intersection of Fifth Street and Indiana Avenue, NW, and struck a parked, unmarked MPD vehicle in the 400 block of Indiana Avenue, NW. A traffic stop was conducted in the 400 block of Indiana Avenue, NW. R/O observed the Suspect swaying and detected the odor of an alcoholic beverage on their person. SFSTs were conducted and, due to numerous signs of impairment, the Suspect was placed under arrest. During a search of the vehicle, a green, leafy substance consistent with Marijuana was found in the center console. The Suspect was transported to Headquarters for processing. CSS responded and processed the scene.

ADDITIONAL CHARGES: POSSESSION OF UNREGISTERED FIREARM/UNLAWFUL POSSESSION OF A FIREARM OR DESTRUCTIVE DEVICE; POSSESSION OF UNREGISTERED AMMUNITION; DRIVING UNDER THE INFLUENCE - 1ST OFF; POSSESSION OF A LARGE CAPACITY AMMUNITION FEEDING DEVICE

R/O responded to the Louisiana Avenue and D Street, NW, security checkpoint for a report of a man with a gun. Upon arrival, R/O observed the Suspect had been removed from his vehicle by R/O-2, who, while conducting a routine check on the vehicle, observed that the Suspect had a semiautomatic pistol on the driver's seat resting between his legs. SFSTs were conducted and, due to numerous signs of impairment, the Suspect was placed under arrest and transported to Headquarters for processing. CSS responded and processed the scene; recovering several large capacity magazines and ammunition from the Suspect's vehicle.
