ADDITIONAL CHARGES: DESTRUCTION OF PROPERTY-MISD

R/O responded to the unit block of Louisiana Avenue, NE, for a report of an unwanted guest. Upon arrival, R/O met with building security who had the Suspect stopped for throwing a brick at a parked vehicle; striking the hood, and entering the unlocked vehicle without permission.
