R/O was located on the Senate steps of the Lower West Terrace when he stopped the Suspect in a restricted area. The Suspect refused to obey R/O's orders to leave the area. The Suspect was placed under arrest and transported to Headquarters for processing.

R/O received two Suspects at USCP Headquarters from R/O-2 after the individuals illegally entered the Capitol Building having defied posted notices barring entry and disregarding warnings from USCP officers. The two Suspects were placed under arrest, decontaminated, and transported to Headquarters for processing.

R/O was on patrol on the first floor on the North side of the Capitol Building when she was shoved and struck by a closed fist several times by the Suspect. The Suspect became combative and resisted R/O's

attempts to gain control of him. The Suspect was placed under arrest and transported to Headquarters for processing.

ASSAULT ON A POLICE OFFICER - MISDEMEANOR

R/O responded to the Lower West Terrace for the report of an Assault on a Police Officer. Metropolitan Police Officers #1 and #2 relayed to R/O that the Suspect struck them multiple times with a Lacrosse-type stick while they were holding the police line at the Lower West Terrace Door. The Suspect was placed under arrest and transported to the hospital for treatment of minor injuries.

SA responded to a call from the Metropolitan Washington Airport Authority at Washington Reagan National Airport. A Suspect had been removed from a flight and was identified as a participant in the riot inside the U.S. Capitol Building on January 6, 2021, through his social media posts. The Suspect was placed under arrest and transported to Headquarters for processing.
