ADDITIONAL CHARGES: POSSESSION OF UNREGISTERED FIREARM/UNLAWFUL POSSESSION OF A FIREARM OR DESTRUCTIVE DEVICE; CARRYING A PISTOL WITHOUT A LICENSE; CARRYING A PISTOL WITHOUT A LICENSE; TRANSPORT OF LOADED HANDGUN

R/O observed the Suspect place a bag on the X-ray machine during an administrative search, at the West Main Door of the Library of Congress Jefferson Building, which contained ammunition inside. Further investigation revealed the Suspect had two handguns inside his parked vehicle. A WALES/NCIC check revealed the Suspect did not possess a license to lawfully carry a weapon in the District of Columbia, and the handguns and ammunition were not registered. The Suspect was placed under arrest and transported to Headquarters for processing. CSS responded and processed the scene.

UCSA - POSSESSION (OTHER)

R/O observed the Suspect standing on the west side of 50 Massachusetts Avenue, NE, trying to conceal an unknown object, which he dropped to the ground. Upon approach, R/O identified the object as a brown-green, leafy substance consistent with synthetic cannabinoids. A stop was conducted at the

same location. The Suspect was placed under arrest and transported to Headquarters for processing. CSS responded and processed the scene.

R/O was posted on a police line established for a demonstration on the East Front of the U.S. Capitol Building when he observed the Suspect cross the police line after being warned not to do so. The Suspect was placed under arrest and transported to Headquarters for processing.

R/O observed a vehicle traveling westbound through the intersection of Third Street and North Carolina Avenue, SE. A WALES/NCIC check revealed the vehicle tag was expired. R/O conducted a traffic stop at the intersection of Third and C Streets, SE. A WALES/NCIC check of the Suspect's ID revealed an expired DC license, a revoked Maryland permit, and no permit in Virginia. The Suspect was placed under arrest and transported to Headquarters for processing.
