R/O responded to New Jersey Avenue and D Street, SE, for a report of a person with a firearm. R/O identified the Suspect operating a vehicle in the 400 block of First Street, SE, and conducted a traffic stop. During the traffic stop, the Suspect advised she had a firearm located in the rear seat of her vehicle. CIS was notified and responded to the scene. CSS responded and processed the scene. The Suspect consented to a search of her vehicle and the firearm was recovered. A WALES/NCIC check of the firearm returned no registration on file. The Suspect was placed under arrest and transported to Headquarters for processing.

R/O observed a vehicle on I-395, in the Third Street Tunnel, travelling through a blinking red light without coming to a complete stop. R/O attempted to initiate a traffic stop in the 900 block of Second Street, NW, but the vehicle fled at a high rate of speed. Later, R/O observed the vehicle stopped in the unit block of Louisiana Avenue, NE, with its driver-side door open and the airbags deployed. A Witness notified R/O that they observed the Suspect run through Lower Senate Park with a black object in his hands. A lookout was broadcast through USCP Communications. R/O-2 detained the Suspect in the unit block of D Street, NE. A canvass of the area revealed a black bag with a handgun inside. CSS responded to process the scene.
