**ADDITIONAL CHARGES: POSSESSION OF DRUG PARAPHERNALIA; FUGITIVE FROM JUSTICE; COUNTERFEIT TAGS; PERMIT REVOKED-OAR**

R/O observed a vehicle in the unit block of H Street, NE, with what appeared to be counterfeit tags. A traffic stop was conducted in the 700 block of Fifth Street, NE. A WALES/NCIC check revealed no tag record on file. Also, a check of the Suspect's license revealed it was revoked in the District of Columbia, as well as an active U.S. Marshals Service warrant for a parole violation in Virginia. During a search incident to arrest, several small bags containing a white-powder substance were discovered in the Suspect's pants pocket. CSS responded to process the scene. A field test of the substance tested positive for heroin/morphine. The Suspect was placed under arrest and transported to Headquarters for processing.
