TRAFFIC - PERMIT -OPERATING AFTER REVOCATION

R/O observed a vehicle traveling southbound on Second Street, SE, cross into the northbound lanes to make a left turn at the intersection of Second Street and Pennsylvania Avenue, SE. A traffic stop was conducted in the 300 block of Pennsylvania Avenue, SE. A WALES/NCIC check revealed the Suspect's permit was revoked in the District of Columbia. The Suspect was placed under arrest and transported to Headquarters for processing.

ADDITIONAL CHARGES: RECEIVING STOLEN PROPERTY \$1000 OR MORE; TRAFFIC - PERMIT - NO VALID

R/O observed a vehicle traveling eastbound in the 200 block of Pennsylvania Avenue, SE, with stolen tags, which was confirmed through USCP Communications. A traffic stop was conducted in the 200 block of Eighth Street, SE. A WALES/NCIC check of the Suspect's identification card revealed no permit on file. The Suspect was placed under arrest and transported to Headquarters for processing. CSS responded to process the vehicle, and CID was notified.

ASSAULT ON A POLICE OFFICER - MISDEMEANOR

ADDITIONAL CHARGES: AGGRESSIVE PANHANDLING; RESISTING ARREST

R/O observed an individual walking in traffic in the eastbound lane of the unit block of E Street, NW, stop and knock on the window of a vehicle stopped at the traffic light. R/O advised the Suspect to move to the sidewalk. The Suspect ignored the R/O's commands and proceeded to walk in traffic toward the 500 block of North Capitol Street, NW. R/O continued directing the Suspect to stop before attempting to detain her. The Suspect actively evaded R/O by attempting to flee, then by striking both the R/O and R/O-2 before being handcuffed and placed under arrest. CSS responded and processed the scene.

DISORDERLY CONDUCT - MISD

ADDITIONAL CHARGE: FAILURE TO OBEY

R/O responded to the intersection of Fourth and C Streets, SE, for a welfare check. Upon arrival, the Suspect began to walk away into the middle of the intersection; lunging at vehicles. The Suspect then jumped onto the roof of a vehicle. R/O gave several commands to stop while the Suspect continued to run. The Suspect was placed under arrest and transported to Headquarters for processing.

CROWDING OBSTRUCTING INCOMMODOING DC CODE 22-1307

R/O observed the Suspects obstructing the flow of traffic by sitting down and blocking the roadway in the 300 block of First Street, SE. ADDITIONAL CHARGE: FAILURE TO APPEAR

R/O was canvassing the area for a wanted male when he stopped a Suspect matching the description in the unit block of First Street, NE. A WALES/NCIC check revealed an active Stay Away Order from Capitol Grounds, and six active bench warrants out of the District of Columbia Superior Court, which were confirmed by USCP Communications. The Suspect was placed under arrest and transported to Headquarters for processing.

ASSAULT ON A POLICE OFFICER - MISDEMEANOR

ADDITIONAL CHARGES: POSS OF A CONTROLLED SUBSTANCE-MISD (48DC904.01D); RESISTING ARREST

R/O was on routine patrol on Massachusetts Avenue and G Street, NE, when he observed a Suspect holding what appeared to be a brown joint. R/O conducted a stop and found a bag containing a controlled substance. The Suspect became non-compliant and fled westbound on G Street. When the R/O located the Suspect, the Suspect physically resisted arrest. R/O-2 responded and assisted in handcuffing the Suspect. The Suspect was placed under arrest and transported to Headquarters for processing.
