R/O observed a vehicle traveling westbound in the unit block of G Street, NE, fail to maintain its lane of travel. A traffic stop was attempted in the 600 block of North Capitol Street, NW. The Suspect

failed to stop and fled the scene, running a red light. R/O observed the vehicle stopped in the unit block of I Street, SW, and conducted a traffic stop. The Suspect became non-compliant and fled south across the unit block of I Street, SW. The Suspect physically resisted R/O, causing them both to fall.
