At approximately 0253 hours, R/O responded to the 200 block of Pennsylvania Avenue, SE, for a report of a vehicle hitting the curb and a generator light. R/O observed a vehicle with damage to the front passenger side, with the Suspect sitting in the driver's seat, in the 300 block of Pennsylvania Avenue, SE. Upon approach, R/O smelled an odor of an alcoholic beverage emitting from the Suspect's breath and vehicle. SFSTs were conducted and, due to numerous signs of impairment, the Suspect was placed under arrest and transported to Headquarters for processing.

R/O observed a vehicle traveling westbound at a slow rate of speed in the unit block of Independence Avenue, SW, and conducted a traffic stop. R/O observed the Suspect in a catatonic state and was unable to respond to questions. When requested, the Suspect stepped out of the vehicle and a wet cigarette fell from the Suspect's lap. CSS responded to process the scene. An additional cigarette and a vial containing an unknown liquid was discovered in the vehicle. Both cigarettes and the liquid substance field tested positive for PCP. The Suspect was placed under arrest and transported to Headquarters for processing.
