Upon approaching the vehicle, R/O observed the Suspect in the driver's seat while the vehicle was still running. R/O detected an odor emitting from the Suspect's breath that is consistent with PCP. SFSTs were conducted and, due to numerous signs of impairment, the Suspect was placed under arrest and transported to Headquarters for processing.

ADDITIONAL CHARGES: UCSA - POSSESSION OF DRUG PARAPHERNALIA (MISD)

R/O responded to the unit block of E Street, NW, to assist R/O-2 with a multiple subject stop. R/O-2 advised he observed three individuals huddled in a doorway, and while speaking to the Suspects, there was a clear zip lock bag containing a white, rock-like substance on the ground. The Suspects consented to a search of their pockets. During the searches, R/O discovered multiple clear zip lock bags containing a white, rock-like substance, a threaded metal pipe, and a clear glass pipe. Field testing of the substance in the clear zip lock bags was conducted, and the substance tested positive for cocaine. The Suspects were placed under arrest and transported to Headquarters for processing.
