ADDITIONAL CHARGES: NO PERMIT; POSS OF A CONTROLLED SUBSTANCE-MISD

R/O responded to the 200 block of Second Street, SE, to assist R/O-2 with a driver found slumped over the steering wheel of a car. R/O-2 attempted to wake the Suspect several times. Upon waking, the Suspect was observed by R/O to be disoriented. A WALES/ NCIC check of the Suspect's driver's license revealed a suspended status in Maryland with no status in the District of Columbia or Virginia. SFSTs were conducted and, due to numerous signs of impairment, the Suspect was placed under arrest and transported to Headquarters for processing. CSS responded to process the scene. During vehicle processing, a scale, several bags containing a white, crystalized substance, a bag containing a brown substance, and a bag containing a white, powdery substance was found.

R/O responded to a report of a heavily damaged vehicle in the 500 block of South Capitol Street. A stop was attempted at that location, and was conducted in the 1300 block of South Capitol Street, SW. Upon approach, R/O detected an odor of an alcoholic beverage emitting from the Suspect.

A WALES/NCIC check revealed a suspended status out of Maryland, and no valid permit in the District of Columbia or Virginia. The Suspect refused to submit to SFSTs. The Suspect was placed under arrest and transported to Headquarters for processing. CSS responded and processed the scene.

ADDITIONAL CHARGES: TRAFFIC-MISUSE OF TAGS; POSSESSION OF A CONTROLLED SUBSTANCE-MISD; POSSESSION OF A CONTROLLED SUBSTANCE-MISD

R/O observed a vehicle in the unit block of G Street, NW, with the rear license plate covered by a trash bag. A traffic stop was conducted in the same location. A WALES/NCIC check revealed that the Suspect's permit is revoked in the District of Columbia, with no status in Maryland or Virginia. An additional check revealed the license plate is registered to another vehicle. The Suspect was placed under arrest and transported to Headquarters for processing. While conducting an inventory on the vehicle, R/O discovered a fuzzy, yellow and brown substance, which field tested positive as Synthetic Cannabinoids, and a white, rock-like substance that field tested positive for Cocaine.
