R/O observed an individual sitting on a park bench in the unit block of Louisiana Avenue, NW, appearing to conceal an object as the R/O approached. During a consensual search, two plastic bags containing a white, rock-like substance were found on the Suspect. R/O was flagged down in the 500 block of New Jersey Avenue, NW, by two individuals who were attempting to stop the Suspect from leaving the scene with multiple items from their store. The Complainants stated the Suspect entered their store and proceeded to consume multiple food items. When the Suspect was confronted by the Complainants, he pushed them out of the way and attempted to leave the scene. R/O detained the Suspect and placed him in handcuffs. R/O-2 and R/O-3 arrived on the scene to assist. While R/O was preparing the barring notice, the Suspect fled the scene. R/O-2 and R/O-3 pursued on foot yelling commands to stop, which the Suspect ignored. The Suspect was apprehended in the unit block of G Street, NW. Subsequently, while apprehending the Suspect, R/O-2 and R/O-3 sustained injuries. The Suspect was placed under arrest and transported to USCP Headquarters for processing.
