#### ADDITIONAL CHARGES: UCSA - OTHER

R/O observed the Suspect, huddled in a cut-out of the wall at 50 Massachusetts Avenue, NE, attempting to conceal an object in his pocket. Upon approach, R/O asked the Suspect if he would reveal what was in his pocket and the Suspect consented. While removing items from his pocket, a ball of tissue fell to the ground. R/O picked up the tissue and discovered two white, rock-like substances inside. A consensual search of the Suspect's pocket revealed a glass pipe and another white, rock-like substance along with another glass pipe inside of the Suspect's backpack. The substance was field tested, and it tested positive for cocaine. The Suspect was placed under arrest and transported to Headquarters for processing.

SFSTs were conducted and, due to numerous signs of impairment, the Suspect was placed under arrest and transported to Headquarters for processing.

R/O observed an altercation between two drivers at the intersection of Second and D Streets, NE. The first Suspect (S-1) was waiting to turn left onto Second Street, NE, when the second Suspect (S-2) threatened to assault him because he would not move his vehicle. S-2 drove onto the sidewalk, showing no regard to pedestrian safety, and began to hit S-1's bumper repeatedly with his driver's side door. R/O requested backup and separated both Suspects. R/O-2 arrived on scene and asked S-2 to turn off and exit his vehicle, but he refused. R/O-2 gave the direct order again before having to remove S-2 from his vehicle. A WALES/NCIC check of S-1 revealed a suspended license in Maryland, with no status in the District of Columbia or Virginia. The Suspects were placed under arrest and transported to Headquarters for processing.

Both warrants were confirmed by USCP Communications. The Suspect was placed under arrest and transported to Headquarters for processing.
